



## **Sponsorship Agreement and Liability Waiver**

Sponsor agrees to provide logos and other promotional materials within seven days of the completion of the sponsorship payment.

6. Termination: Either party may terminate this Agreement with written notice if the other party breaches any material term or condition of this Agreement. In such cases, the breaching party shall have 15 days to cure the breach before the Agreement may be terminated.

7. Governing Law and Jurisdiction: This Agreement shall be governed by and construed in accordance with the laws of the state of Virginia. Any disputes arising under or in connection with this Agreement shall be subject to the exclusive jurisdiction of the state and federal courts located in Virginia.

8. Entire Agreement: This Agreement constitutes the entire agreement between the Sponsor and the Organizer, superseding any prior oral or written agreements or understandings.
